You may now apply to receive an Absentee Ballot by mail for the June 17, 2025 Special Primary Election. We will begin to mail Absentee Ballots on May 27, 2025 through June 6, 2025. If you would like to receive an Absentee Ballot by mail, a completed absentee ballot application must be submitted to our office no later than June 6, 2025.

Advance Voting for the June 17, 2025 Special Primary Election will be available May 27, 2025 through June 13, 2025, Monday through Friday, 8:00am to 5:00pm. Saturday Voting will be available on May 31, 2025 and June 7, 2025, 9:00am to 5:00pm.

Please note - Advance Voting will **only** be available at building G3 in Evans, which is located 610 Ronald Reagan Drive, Evans, GA 30809.

The deadline for Voter Registration to be eligible to vote in the June 17, 2025 Special Primary Election is May 19, 2025.

On Election Day, June 17, 2025 all regular and established precincts will be open from 7:00am to 7:00pm. **If you vote on Election Day, you must go to your assigned precinct.**

The Board of Elections will vote on relocating the voters of this precinct for the next scheduled election. Due to previously scheduled Vacation Bible School, Parkway Baptist Church will not be able to accommodate voting for the June 17, 2025, Special Primary Election and any associated Runoff (if needed). No person shall tally or tabulate, estimate or cause the voting equipment to produce any tally or tabulation, partial or otherwise, until the closing of the polls.
