Consolidation of Precinct 120/Harvest Pointe Fellowship and Precinct 065/Christ Sanctified Church and New Boundaries of Precinct 065/Christ Sanctified Church and the Dissolution of Precinct 120/Harvest Pointe Fellowship

Public Notice of Election Day Precinct Boundary Modification the Columbia County Board of Elections does hereby provide notice, as required in O.C.G.A. §§ 21-2-262(a) and 21-2-262(c), of a change of precinct boundaries involving the 120/Harvest Pointe Fellowship and the 065/Christ Sanctified Church precincts. In order to account for the church's relocation of Harvest Pointe Fellowship, the proposed boundary modification will adjust the boundary lines for Precinct 120/Harvest Pointe Fellowship and Precinct 065/Christ Sanctified to reflect the consolidation of the two precincts, with the polling location being 065/Christ Sanctified Church. Precinct boundary maps are currently on file in the Board of Elections Office, 610 Ronald Reagan Drive, Building G3, Evans, GA 30809, and any affected or interested citizens are encouraged and invited to view the maps at that office. The available maps will depict the current precinct boundaries as well as the proposed boundaries.

Dissolution of Precinct 070/Blanchard Park and New Boundaries of Precincts 076/Westminster Presbyterian Church and 085/Trinity Baptist Church

Public Notice of Election Day Precinct Boundary Modification the Columbia County Board of Elections does hereby provide notice, as required in O.C.G.A. §§ 21-2-262(a) and 21-2-262(c), of a change of precinct boundaries involving the 070/Blanchard Park, 076/Westminster Presbyterian Church, and 085/Trinity Baptist Church precincts. In order to account for the age and size of the facility along with the delayed completion of a new facility at Blanchard Park, the proposed boundary modification will adjust the boundary lines for 076/Westminster Presbyterian Church and 085/Trinity Baptist Church precincts to inherit the voters from 070/Blanchard Park, with the surviving polling locations being 076/Westminster Presbyterian Church and 085/Trinity Baptist Church. Precinct boundary maps are currently on file in the Board of

Elections Office, 610 Ronald Reagan Drive, Building G3, Evans, GA 30809, and any affected or interested citizens are encouraged and invited to view the maps at that office. The available maps will depict the current precinct boundaries as well as the proposed boundaries.

Consolidation of Precinct 105/Savannah Rapids Pavilion and 109/ Stevens Creek Community Church and New Boundaries of Precinct 109/Stevens Creek Church and the Dissolution of Precinct 105/Savannah Rapids Pavilion

Public Notice of Election Day Precinct Boundary Modification the Columbia County Board of Elections does hereby provide notice, as required in O.C.G.A. §§ 21-2-262(a) and 21-2-262(c), of a change of precinct boundaries involving the 105/Savannah Rapids Pavilion and 109/Stevens Creek Community Church precincts. In order to account for the damage to the voting facilities located at Savannah Rapids Pavilion from Hurricane Helene, the proposed boundary modification will adjust the boundary lines for 105/Savannah Rapids Pavilion and 109/Stevens Creek Community Church precincts to consolidate the precincts into one, with the polling location being 109/Stevens Creek Community Church. Precinct boundary maps are currently on file in the Board of Elections Office, 610 Ronald Reagan Drive, Building G3, Evans, GA 30809, and any affected or interested citizens are encouraged and invited to view the maps at that office. The available maps will depict the current precinct boundaries as well as the proposed boundaries.

The proposed changes in the above-mentioned precinct boundary and polling location notices are being considered and may be approved and become final at the monthly board meeting on March 18, 2025, or if need be, April 15, 2025, and will be in effect with the next election, which is currently scheduled for June 17, 2025. Voters affected by a change in precinct/polling place change will be mailed a written notification. Any person objecting to these modifications must file his or her objections via written notification with the Director prior to March 18, 2025.
